SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation	If spray/mist has been inhaled, proceed as follows. Remove affected person from source of contamination. In the event of any sensitisation symptoms developing, ensure further exposure is avoided.
Ingestion	Give plenty of water to drink. Give milk instead of water if readily available. Keep affected person under observation. If in doubt, get medical attention promptly. Get medical attention if a large quantity has been ingested.
Skin contact	Remove contaminated clothing and rinse skin thoroughly with water. Get medical attention if symptoms are severe or persist after washing. In the event of any sensitisation symptoms developing, ensure further exposure is avoided.
Eye contact	Remove any contact lenses and open eyelids wide apart. Rinse immediately with plenty of water. Continue to rinse for at least 15 minutes. Get medical attention if any discomfort continues.
